## **Public Health Suffolk – Bim Templeman**

**BT** advises group that Public Health Suffolk is now part of SCC, and there is a new structure as a result. This includes an overall Director, 3 Lead Consultants, Commissioning Team, and Community Engagement.

### Action Point - BT to email full structure to CL to circulate

**BT** states that funding to various areas (eg drug & alcohol, smoking, obesity) is no longer ring-fenced and can be allocated where appropriate.

Current providers have been given notice of a requirement to re-tender for 2014, but have had their current contracts extended to allow this to take place. The aim is that the "new" providers shadow the existing ones to allow full takeover April 2015.

# Action Point – BT to email letter outlining this to CL for circulation

**BT** talks of a major stakeholder event November this year to introduce concept of uniting drug & alcohol services for both the young and adults, with a view to achieving seamless treatment, and thereby avoid current transfer problems.

**BT** advises group of available DAAT comprehensive training with online registration through Customer Service Direct. They also offer bespoke training for groups (min 6) – eg Legal Highs. <a href="https://www.suffolkcpd.co.uk">www.suffolkcpd.co.uk</a> Action Point – BT to email to CL for circulation

**BT** also talks of the Recovery Grant Scheme (£500 - £5K) available for Voluntary & Community Groups to assist them with working with people in recovery. This will be relaunched in October.

**BT** gives the following dates for informal network recovery meetings:- 19/9 (East Coast Recovery in Lowestoft) & 27/9 in Bury St Edmunds. Also 1/10 is Strategic Partnership Dav.

**BT** updates group on progress of "Strength" campaign advising this has been such a success in Ipswich that the one remaining shop selling super-strength alcohol in town will be given notice to stop by the Council.

### Richard Squirrell

RS updates group (following his noted experience in the July minutes) on the telephone numbers for service-users to contact CMHT. RS feels service is inappropriate and unprofessional. He has had to leave messages in office hours, and is not confident that these were responded to. He even asked for Debbie White and was told no-one of that name worked there. SM endorses this and has already had a meeting with Debbie White in this respect; as SM has found that her messages for Care Co-Ordinators are not getting through. Apparently Debbie acknowledged communication with both Service-Users and care-givers poorly managed. SM will update group once she receives formal response

**LB** has 3 clients who are due to change Care Co-Ordinator in less than a month but still do not have the name of the new person.

Action Point – DG to feedback these concerns over communication to Main Vasp, & invite Debbie back to Ipswich Vasp; and GP to feedback to Board

**RS** repeats his concern that SCC apparently continue to increase their investment in Tobacco Companies.

**RS** would also like the success (over 400 attendees) of the Recovery Roadshow to be celebrated. **BM** advises that they are currently considering whether to repeat this again, and will update us shortly once decision made.

**RS** also advises that SAT website appears to be 18 months out of date – BM advises SAT are independent of PH but she will feed this back to them.

**RS** also repeats his request for support for the abstinent, and reminds **DG/LM** of his request for statistics on the success of the weekly recovery sessions run by SAM Project? **Action Point – DG to investigate** 

**RS** raises concern over the payment of £10/hr plus travel costs to service-users who attend consultation meetings due to potential DWP penalty for non-declaration of "Change of Circumstances". **RS** feels this funding would be better used to provide respite or support. Group discussion on whether this is encouraging the right people to attend, and concern that the feedback received could be distorted as a result **GP** clarifies that this is misunderstanding of the strategy and that payment of up to £10 is only available where the service-user is making significant contribution to meeting (eg making a presentation) – attendance alone is not a qualifying factor.

### **Open Road – Jason Berry**

**JB** advises they receive all their referrals from CRI – and they offer a range of services including complimentary therapy, individual work, and Foundations of Recovery (group sessions of 8 weeks)

**JB** advises that they can offer significantly improved service with access to 4 counsellors; and although abstinence is the ultimate aim it is not necessarily a requirement.

Action Point - LM to invite Community Engagement Officer for E Ipswich to Vasp.
