1. Welcome and apologies

2. Charlotte Green from Suffolk MIND on "Peer Support Networks". Charlotte explained how a PSN network operates and also how members are trained in the techniques that are used. - 5. CAMHS initiative update; Sudbury and Mid Suffolk events
 SP has been negotiating with Anne-Marie Childs and Gareth Moir, (Locality
 Community Development Officers for South and Mid suffolk, SCC.), for a
 single CAMHS gathering/conference instead of two. SP meeting with
 Anne-Marie on 9/1/2013 to discuss timing, structure, speakers etc for this
 event.
- 6. "Mental Health Cop" blog
 SP recommended the blog to VASP members as she found the content to be excellent
- 7. Problems with access to treatment

BB reported on a case which had caused concern: a mother has been unable to get help for her adult son who is suffering from mental ill health. She has been unable to refer him to either her own or her son's GP as they have told her he has to self refer. The son is not in a position to do this so is not accessing help. BB stated that this policy on not being able to refer on behalf of someone else is too rigid.

A discussion took place at the VASP meeting, with suggestion that mother writes a letter to local authority, asks to speak to Link Worker, rings CMHT, rings Customer First to get a POVA (Protection of Vulnerable Adult).

SP stated that there is a general lack of referring from GPs. KB suggested that the issue be taken to Healthwatch or SUF. She said she had had a similar experience to BB's contact.

SP urged members to join Healthwatch.

Action: SP to look at feeding Mid Suffolk VASP concerns to Healthwatch, SUF and Link Workers.

8. Spring ASDA Stowmarket event

SP suggested 18th or 25th April for the event in the Stowmarket ASDA foyer.

9. AOB

Members were reminded of the SUF forum to take place at Red Gables on 11^{th} February.

10. Members discussed setting up a criminal justice system VASP. Kathleen and SP had been on an earlier forum which had been organised by the NHS. NHS had pulled out leave the VASP with no admin support.

KB suggested that the VASP should be set up in partnership with the police, CPs, courts and prisons.

SP and KB to meet with Independent Monitoring Board representative.
